**END-USER LICENSE AGREEMENT**  
**FOR ALL SOFTWARE COMPONENT PRODUCT(S)**

Definitions: This Theobald Software License Agreement ("EULA") is a legal agreement between you (either as an individual user, corporation or single entity) and Theobald Software GmbH for the Xtract RS product which includes computer software, and may include associated media, printed materials, and online or electronic documentation ("SOFTWARE PRODUCT" or "SOFTWARE"). By exercising your rights to install Xtract RS, you agree to be bound by the terms of this EULA, including the limitations and warranty disclaimers. If you do NOT agree to the terms of this EULA, you may not install nor use Xtract RS;

SOFTWARE PRODUCT LICENSE

Xtract RS is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties.

1. GRANT OF LICENSE.

This is a license agreement, and NOT an agreement for sale. Theobald Software GmbH retains ownership of the copy of Xtract RS in your possession, and all copies you may be licensed to make. Theobald Software GmbH retains all rights not expressly granted to you in this LICENSE. Theobald Software GmbH hereby grants to you, and you accept, a non-exclusive, non-transferable license to use and copy Xtract RS only as authorized below.

Provided that you have accepted these terms contained herein, this EULA grants you the following rights:

**Installation and Use:**

**Enterprise License:** You are granted a license for all developers (individuals) of your company and contractors that you authorized to use the software on your company's behalf on one specific named server. At no time may Xtract RS be used by non-employed individuals of your organization for any purposes - nor may Xtract RS be distributed to any place outside your organization.

**Enterprise Subscription License:** You are granted a license for all developers (individuals) of your company and contractors that you authorized to use the software on your company's behalf on one specific named server. The subscription is timely restricted. After the expiration of the contracted period the subscription will be renewed automatically for another year, if the contract is not cancelled in accordance with the notice period. At no time may Xtract RS be used by non-employed individuals of your organization for any purposes - nor may Xtract RS be distributed to any place outside your organization.

**Test License for non-production use:** You are granted a license for non-production use for your testing purposes. This includes all rights and responsibilities associated with the Enterprise license.

**Trial License:** This includes all rights and responsibilities associated with the Enterprise License for a limited amount of time. This license may only be used for purposes related to your initial internal evaluation and proof-of-concept activities and shall not be used for development or testing purposes, even on a temporary basis, after a commercial license has been purchased.

For All Licenses: In no case shall you rent, lease, lend, redistribute nor re-license Xtract RS or source code to a 3rd party individual or entity, except as outlined above. In no case shall you grant further redistribution rights for Xtract RS to the end-users

of your solution.

## 2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

Termination. Without prejudice to any other rights, Theobald Software GmbH may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of Xtract RS and all of its component parts, source code, associated documentation, and related materials.

## 3. COPYRIGHT.

All title and copyrights in and to Xtract RS (including but not limited to any images, photographs, animations, video, audio, music, text, and "applets" incorporated into Xtract RS), the accompanying printed materials, and any copies of Xtract RS are owned by Theobald Software GmbH. Xtract RS is protected by German copyright laws and international treaty provisions. Therefore, you must treat Xtract RS like any other copyrighted material.

## 4. LIMITED WARRANTY.

NO WARRANTIES. Theobald Software GmbH expressly disclaims any warranty for Xtract RS. Xtract RS and any related documentation is provided "as is" without warranty of any kind, either express or implied, including, without limitation, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement. The entire risk arising out of use or performance of Xtract RS remains with you.

## 5. LIMITATION OF LIABILITY.

NO LIABILITY FOR CONSEQUENTIAL DAMAGES. In no event shall Theobald Software GmbH or its distributors be liable for any damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use this Software and related materials, even if Theobald Software GmbH has been advised of the possibility of such damages. Because some states do not allow the exclusion or limitation of liability for consequential or incidental damages, the above limitation may not apply to you.
